THE BUSINESS MODEL AND FINANCIAL ARRANGEMENT BETWEEN SAMARKANDSTATE UNIVERSITY AND UNIVERSITI TEKNOLOGI MALAYSIA SPACE

Discussion on 9 March 2019 at 10am at Samarkand State University

The following items areagreed by both parties on 9 March 2019 in order to firm up the business model and financial arrangement of the franchise model between SAMARKANDSTATE UNIVERSITY and UTM and UTM SPACE.

1. Undergraduate programmes- 2 + 2 Hybrid Model

- (1) Bachelor of Electronic Systems Engineering and
- (2) Bachelor of Mechanical Precision Engineering
 - The first year and the second year to be conducted at Samarkand State University
 - The third year and the fourth year to be conducted at UTM
 - The degree awarding bodyfrom UTM

a. Tuition fees to be imposed to each student

- First and Second Year = Total amount of Tuition Fees to be capped at a minimum of RM37,000 (=USD9250)
- ii. Third and Fourth Year = Total amount of Tuition Fees to be capped at a minimum of RM41000 (USD10,250)

2. Management fee

Management fee to be imposed to SAMARKAND STATE UNIVERSITY

a. Undergraduate degree for each programme (for the first and the second year) = USD 1000 per student per semester

3. Minimum number of students per programme

- a. Undergraduate
 - i. Minimum payment that based on the number of students enrolled on each programme
 - 20 students/programme/semester
 - ii. Minimum payment that based on the number of students enrolled on each programme after 4 semesters
 - 80 students

4. Development Fee

Development fee for each programme = USD 12000 (one-off payment) over 3 semesters

5. UTM Validation Certificate

Validation certificate fee per programme = USD 3,000 per year

6. Engineering Accreditation Council (ECA) Validation

Validation visit and certification to be borne by Samarkand State University

7. Flight/Accommodation/meals/travelling expenses

All expenses that include flight, accommodation, meals, honorarium & teaching allowance and other travelling expenses for Malaysian Qualifications Agency (MQA), validation visits, teaching, quality visits, programme review, train on trainers and relevant visits to be absorbed by SAMARKAND STATE UNIVERSITY.

8. Security Deposit

Security Deposit will be waived as Samarkand State University is a public university.
