



## AGREEMENT OF COOPERATION BETWEEN THE DEPARTMENT OF BIOLOGY – UNIVERSITY OF PISA, ITALY AND THE FACULTY OF BIOLOGY – SAMARKAND STATE UNIVERSITY, SAMARKAND

The Department of Biology – University of Pisa, situated at Via Luca Ghini 13, 56126 Pisa, Italy, represented by the Director Prof. Alberto Castelli and the Faculty of Biology – Samarkand State University, situated at University Boulevard,15, Samarkand, Uzbekistan, represented by the Dean, Dr. Hudoyer Keldiyorov, wishing to enhance relations between the two structures and to develop academic and cultural interchange in the areas of research, and other activities, agree to cooperate and work together toward the internationalization of higher education.

The areas of cooperation will include any program offered at either structures which is felt to be desirable and feasible for the development and strengthening of cooperative relationships between the two institutions. However, any specific program shall be subject to mutual consent, availability of funds, and approval of each party. Such program may include:

- a. Exchange of teachers, researchers, technical and administrative staff
- b. Exchange of undergraduate, graduate, doctoral and post-doctoral students
- c. Joint research projects
- d. Joint conferences
- e. Joint cultural programs
- f. Exchange of academic materials, publications, and other documentation.

The terms of such mutual assistance and cooperation shall be discussed and agreed upon in writing by the appropriate responsible officers of both parties prior to the initiation of any particular program or activity.

The validity of this agreement is subject to the conditions and recommendations of the approval process of both parties being satisfied; its terms may be amended at any time by mutual written consent of both parties.

The present agreement will come into force following the date of the last signature and will have a term of 5 years.

The agreement may be renewed for further periods by mutual written consent of the parties; however, after the initial period either party may terminate the agreement by giving six months notice in writing of such intent.

The parties agree to solve in a friendly manner any controversy rising from the interpretation of the present agreement.


