MEMORANDUM OF UNDERSTANDING

between

SAMARKAND STATE UNIVERSITY NAMED AFTER SHAROF RASHIDOV (UZBEKISTAN)

and

WISMA LINCOLN UNIVERSITY COLLEGE (MALAYSIA)

This Memorandum of Understanding (MoU) is made on this day _____ 2022

BETWEEN

SAMARKAND STATE UNIVERSITY NAMED AFTER SHAROF RASHIDOV, an institution of higher learning and a body incorporated in Uzbekistan whose address is 140104, University blvrd. 15, Samarkand city, Uzbekistan (hereinafter referred to as "**SamSU**") and shall include its lawful representatives and permitted assigns of the first part;

AND

LINCOLN UNIVERSITY COLLEGE (MALAYSIA) Malaysia whose address is Wisma Lincoln. o. 12-J, Jalan S 6/12, 47301 Petaling Jaya, Selangor Dami Ehsan, Malaysia, (hereinafter referred to as "**LUC**") and shall include its lawful representatives and permitted assigns of the second part.

(SamSU and LUC are hereinafter individually referred to as "Party" and collectively referred to as "Parties")

THE PARTIES HAVE REACHED AN UNDERSTANDING AS FOLLOWS:

1. OBJECTIVE

The Parties, subject to the terms of this MOU and the laws, rules, regulations and national policies from time to time in force in each party's country, will endeavour to strengthen, promote and develop co-operation between the Parties on the basis of equality and mutual benefit

2. AREAS OF CO-OPERATION

- 2.1 Each Party will, subject to the laws, rules, regulations and national policies from time to time in force, governing the subject matter, endeavour to take the necessary steps to encourage and promote co-operation in the following areas:
 - (a) Establishing International Language School
 - (b) Establishing International IT Research Centre
 - (c) Establishing Joint Faculty, International University branch
 - (d) Management
 - (e) Investment in Education:
 - (f) Consultations for Higher Education;
 - (g) Design Undergraduate and Postgraduate academic programs with international standard;
 - (h) Skills and capacity building for staff and student;
 - (i) Training and development;
 - (i) International student recruitment and Marketing support
 - (k) any other areas of co-operation to be mutually agreed upon by the Parties from time to time.

- 2.2 For the purpose of implementing the co-operation in respect of any area in sub-clause 2.1, the Parties may enter into a legally binding agreement subject to terms and conditions as mutually agreed upon by the Parties.
- 2.3 For the promotional purposes, the Parties may, as it deems appropriate, include the hyperlink of each Party in the official website, respectively.

3. FINANCIAL ARRANGEMENTS

- 3.1 This MoU will not give rise to any financial obligation by one Party to the other.
- 3.2 Each party will bear its own cost and expenses in the implementation of this MoU.

4. EFFECT OF MoU

This MoU serves only as a record of the Parties' intentions and does not constitute, and is not intended to constitute or create, obligations under domestic or international law and will not give rise to any legal process and will not be deemed to constitute or create any legally binding or enforceable obligations, express or implied.

5. ENTRY INTO EFFECT AND DURATION

- 5.1 This MoU will come into effect on the date of signing and will remain in effect for a period of one (2) years unless terminated earlier by mutual agreement by giving to each other six (6) month's written notice of intention to terminate this MOU.
- 5.2 This MoU may be extended for a further period as may be agreed in writing by the Parties.

6. REVISION, VARIATION AND AMENDMENT

- 6.1 Either Party may request in writing a revision, variation or amendment of this MoU.
- 6.2 Any such revision, variation or amendment agreed to by the Parties shall be in writing and shall form part of this MoU.
- 6.3 Such revision, variation or amendment shall come into force on such date as may be determined by the Parties.
- 6.4 Any revision, variation or amendment shall not prejudice the implementation of any project, activity or co-operation arising from or

based on this MoU before or up to the date of such revision, variation or amendment.

7. NOTICES

7.1 Any communication under this MOU shall be in writing in the English language and delivered by registered mail to the address or sent via electronic mail or facsimile number of **SamSU** or **LUC** as the case may be, shown below or to other such address or electronic mail address or facsimile number as either Party may have notified the sender and shall, unless otherwise provided herein, be deemed to be duly given or made when delivered to the recipient at such address or electronic mail address or facsimile number which is duly acknowledged:
