#### SAMARKAND STATE UNIVERSITY NAMED AFTER SHAROF RASHIDOV

#### **Introduction**:

In order to help students at Samarkand State University achieve their present and long-term objectives, the university created its first and foremost student organization in 2021. This organization has been proactively addressing student issues since its beginning and has drawn students for the implementation and raising awareness of various social, cultural, and environmental challenges.

However, a strong legislative framework was published by the Ministry of Higher Education, Science, and Innovation of the Republic of Uzbekistan and the Central Council of the Youth Union of Uzbekistan on March 29, 2023, titled "On Measures to Improve the Activities of Primary Organizations of the Youth Union Uzbekistan in Higher Education Institutions," to give such organizations the necessary legal status.

#### General Rules:

- 1. This rule outlines the status, primary responsibilities, rights, and obligations of the university's first youth union organization (Next, the main organization) and the institutional underpinnings of its operations.
- 2. The initial organization is created by the initiative of at least five young people from the university who are sympathetic to the goals and objectives of the Union and is registered by the regional councils of the Union.
- 3. The primary organization is to educate students and young people at the university to be spiritually, morally and physically perfect, to strengthen the spiritual and ideological outlook of the community, to protect their rights and interests. It is the lowest structure of the Youth Union of Uzbekistan, which is active in increasing its social activity, and is subordinate to the Central, regional and local Councils of the Youth Union of Uzbekistan in its activities.

- 4. The primary organization carries out its activities in cooperation with the university management and other structures of the university.
- 5. In its activities, the primary organization of the Union shall comply with the Constitution and laws of the Republic of Uzbekistan, decrees, decisions and orders of the President of the Republic of Uzbekistan, decisions and orders of the Cabinet of Ministers, the Charter of the Youth Union of Uzbekistan, as well as this Regulation and other legal documents.

#### **Goals and Objectives of Primary Organization:**

- 1. The main goal of the primary organization is to protect the rights and interests of students at the university, to strengthen their spiritual and ideological worldview, to support talented young people in every way and to increase their social activity, to meaningfully organize their free time, students and youth is to support the implementation of initiatives.
- 2. The primary organization has the following tasks:
  - Preparation of proposals for practical measures aimed at supporting students and young people at the university, protecting their legal rights and interests;
  - organization of social and legal protection of students and youth, who needs social
    protection, orphans and those deprived of their parent's care, as well as social
    rehabilitation and social adaptation of students and youth who are victims of crime
    or prone to commit crimes participation in the implementation of measures;
  - To educate students and youth in the spirit of love and loyalty to the motherland, to inculcate the idea of national independence, national values, religious tolerance, inter-ethnic harmony and family values into the minds of the students;
  - To educate students and youth about the civil rights and duties defined in the Constitution and laws of the Republic of Uzbekistan, to explain to them the content and essence of the reforms implemented in the field of state policy regarding youth in the country;
  - Reviewing and helping to solve the problems and appeals of students and youth;
  - Implementation of measures aimed at the student-youth's in-depth knowledge acquisition, foreign language learning and thorough mastering of modern information and communication technologies, as well as their career orientation;
  - To discover talented young people at the university, to implement work aimed at supporting and encouraging them in every way, to organize the activities of clubs and circles that help to develop their intellectual and creative abilities;
  - To widely promote reading books among young people at the university, to increase the love of reading and to develop the culture of reading;
  - Formation of ideological immunity among university students against harmful vices under the guise of "popular culture", information attacks, religious fanaticism, missionary and extremist ideas;
  - Development of youth tourism among university students, organization of visits to historical monuments, sacred sites, museums, theaters, structures built during independence in the area where they live;

- Widely promoting sports among university youth, especially women, supporting their interest in sports and creating favorable conditions for their participation in various sports competitions;
- Organization of promotional events aimed at wide explanation of medical culture, in particular, ways to protect against diseases, to university youth;
- Promoting ecology and environment protection, rational use of natural resources among university youth, raising environmental culture, and supporting environmental initiatives.

#### **Rights and Obligations of Primary Organization:**

The primary rights and obligations of the primary organization are as follows:

- Participation in educational and other processes aimed at protecting the rights and interests of students, obtaining necessary information from responsible employees and teachers, and monitoring;
- Studying the quality of classes at the university, the relationship of professors and students, as well as the activities of the library and sports facilities, conducting social surveys;
- Submitting proposals to the rector of the university and higher organizations regarding the problems, proposals, and initiatives of students and youth;

#### The obligations of the primary organization are as follows:

- To operate within the framework Current normative legal documents of the Republic of Uzbekistan, the local documents adopted by the Youth Union of Uzbekistan and the university, and to comply with the procedures established in them;
- Fulfilling the relevant tasks and instructions of the Ministry of Higher Education, Science and Innovation, the high-ranking Councils of the Youth Union of Uzbekistan, the university management, related to the tasks and activities of the primary organization.;
- Submit quarterly reports on their activities to the relevant regional Council of the Youth Union of Uzbekistan and the university management;
- Proper use of the rooms, material and technical means and funds allocated for the start-up organization.;
- To support the educational, upbringing and other activities of the university.

The organizational structure of the primary organization.

#### The organizational structure of the primary organization includes:

- general meeting of the primary organization;
- Primary organization Youth Council (Primary organization consists of youth leader, direction coordinators;
- Coordinators of the primary organization in the faculty; coordinators of the primary organization in the academic group;

• Structures under the initial organization (circles, clubs, associations, movements, etc).

#### **General Meeting of the primary organization:**

The general meeting of the primary organization is the executive body of the primary organization. The primary organization is a meeting of the report at least once a year in order to listen to the reports of the youth leader, members of the Youth Council and faculty coordinators, making decisions on them. a competent general meeting is convened at least once every two years on the other powers established in this regulation. The decision to convene a general meeting is made by the Youth Council meeting. The decision to convene a general meeting is considered to have been made if at least two-thirds of the Youth Council members (coordinators)voted in favor of it. The decision and agenda to call it will be published at least two weeks before the general meeting.

The General Assembly has the right to consider all issues related to the activities of the primary organization and make the appropriate decision on them.

#### The General Assembly's mandate includes:

- Decision to reorganize the initial organization and end its activities;
- Listening to the reports of the youth leader of the primary organization, members of the Youth Council and the coordinator of the faculty, making decisions on them;
- Election of the composition of the Youth Council of the primary organization;

Decisions on reorganization and termination of the primary organization are considered to be made when two-thirds of the delegates of the general meeting vote for them. Decisions on other issues are considered adopted if the majority of the participants of the general meeting vote for them;

The general meeting of the primary organization is considered authorized to make a decision if two-thirds of the elected delegates participate in its work;

Delegates of the general meeting of the primary organization are elected at the expanded meeting of faculty coordinators and coordinators of academic groups. The standard of representation of the delegates elected to the general meeting, the election procedure, the agenda of the general meeting and the date of its holding are determined by the meeting of the Youth Council of the primary organization.

The Youth Council of the primary organization is the leading body of the primary organization between general meetings and is elected for a period of 2 years in the composition of not less than seven members.

#### Youth Council of the primary organization:

The primary organization Youth Council is headed by the youth leader of the primary organization of the Union at the university.

#### According to the positions held by the Youth Council:

• Youth leader;

- Coordinator of intellectual projects;
- Coordinator of Five Initiative Projects;
- Coordinator of military-patriotic projects;
- Coordinator of entrepreneurship and innovation projects;
- Coordinator of "Youth Notebook" and patronage programs;
- Press and media direction;
- Volunteer school coordinator:
- Includes a female student coordinator.

#### The youth leader performs the following tasks:

- Leads the activities of the primary organization;
- Coordinates the effective organization of the activities of the primary organization, directs the activities of youth leaders of the faculties Youth Councils and groups, provides methodological support to the activities of all leaders in the system, supports the proposals and initiatives of members, students and youth;
- Leads the activities of the primary organization of the Union at the university; protects the rights and interests of university students; organizes the activities of the primary organization and works on behalf of the affiliate; provides requested information, information and reports on the activities of the primary organization to the head of higher organizations and the university;
- It works on the basis of the nomenclature established for the primary organization, ensures the fulfillment of the tasks of the heads of higher organizations and the rector of the university;
- It ensures targeted use of the rooms, material and technical means and funds allocated for the start-up organization.;
- Acts as a member of existing collegial bodies, including councils, working groups, and other youth-related commissions created to protect and support the rights and interests of the University Council, students-youth, young pedagogues, employees.

The youth leader of the primary organization is the adviser of the university rector on youth issues and directly reports to the Regional Council of the Youth Union of Uzbekistan and the university rector.

#### **Faculty coordinator of the primary organization:**

It is considered a branch of the primary organization that is established in existing faculties and operates at the level of the same faculty.

The youth leader of the faculty was elected by a majority of the students studying at the faculty at a meeting held with the participation of youth leaders in academic groups and active-initiative students of the faculty. is elected.

#### **Academic group coordinator of the primary organization:**

- The academic group coordinator of the elementary organization is the subordinate link of the elementary organization that organizes the work at the group level;
- The coordinator of the group is elected by a majority vote among the students of the group in academic groups with at least 20 students in the university. If the number of students in the academic groups is less than 20, the youth leader of the group is elected in the section of directions or courses.

#### Structures under the primary organization (circles, clubs, etc.):

- A primary organization can create various structures in the university based on its goals and objectives and the wishes and desires of students and youth, including clubs, clubs, associations, volunteer groups, movements and administration;
- The work of these structures is supervised by the coordinators of the relevant areas of the Youth Council of the primary organization.

#### Elect the youth leader of the primary organization:

- The election of the youth leader is held at the general meeting of the primary organization through open voting based on the general, equal, direct suffrage of the meeting participants.
- The primary organization has the right to nominate candidates for youth leadership by the Youth Councils of the faculties of the university, student initiative groups in agreement with the rector of the university.
- The selected candidates will be sent for an interview by the selection commission under the relevant regional councils of the youth union of Uzbekistan on the recommendation of the university rector.
- Candidates who have passed the interview of the selection commission have the right to participate in the Youth Leader election process at the general meeting of the primary organization.

#### **Candidates for the position of youth leader:**

- At the time of the election, a student, a master's degree, a basic doctoral student or a university pedagogue who is not older than 35 (thirty-five) years old and has experience working with young people;
- Leadership, leadership ability. oratory skills, initiative and self-sacrifice;
- Management ability, organization, knowledge and skills in working with the public and certain work experience;
- Sufficient understanding of destructive ideas and ideologies, moral threats, harmful vices that have a negative impact on the education of young people;
- It is necessary to have accurate information about the reforms being carried out in the country, the state policy regarding youth and the regulatory and legal documents related to the educational process.

Candidates for youth leadership will be given 10 days (ten days) to conduct election campaign. Candidates introduce their programs to the electorate during this period:

- The preparation and conduct of the election of the youth leader will be carried out in an open and transparent manner;
- The election campaign will be stopped one day before the election day;
- The candidate who has received the most votes of the delegates at the general meeting of the primary organization is elected as the youth leader;
- The youth leader elected at the general meeting of the primary organization will carry out his activities for 2 (two) years.

In mass media and social networks, it is possible to cover the progress of election preparations and how the election is taking place.

#### Financial support of the primary organization:

- The university will provide the primary organization with a separate room, desks and chairs, shelves, a set of computers, a printer, a projector, a screen, a digital camera, and necessary office supplies.
- The measures defined in the work plan of the primary organization are included in the work plan of the university.

The Central Council of the Youth Union of Uzbekistan provides normative legal documents, methodological manuals and handouts related to the activities of the primary organization.

#### **Termination of the primary organization:**

If there are valid reasons to stop the activity of the primary organization, its activity will be terminated in accordance with the decision of the general meeting.


